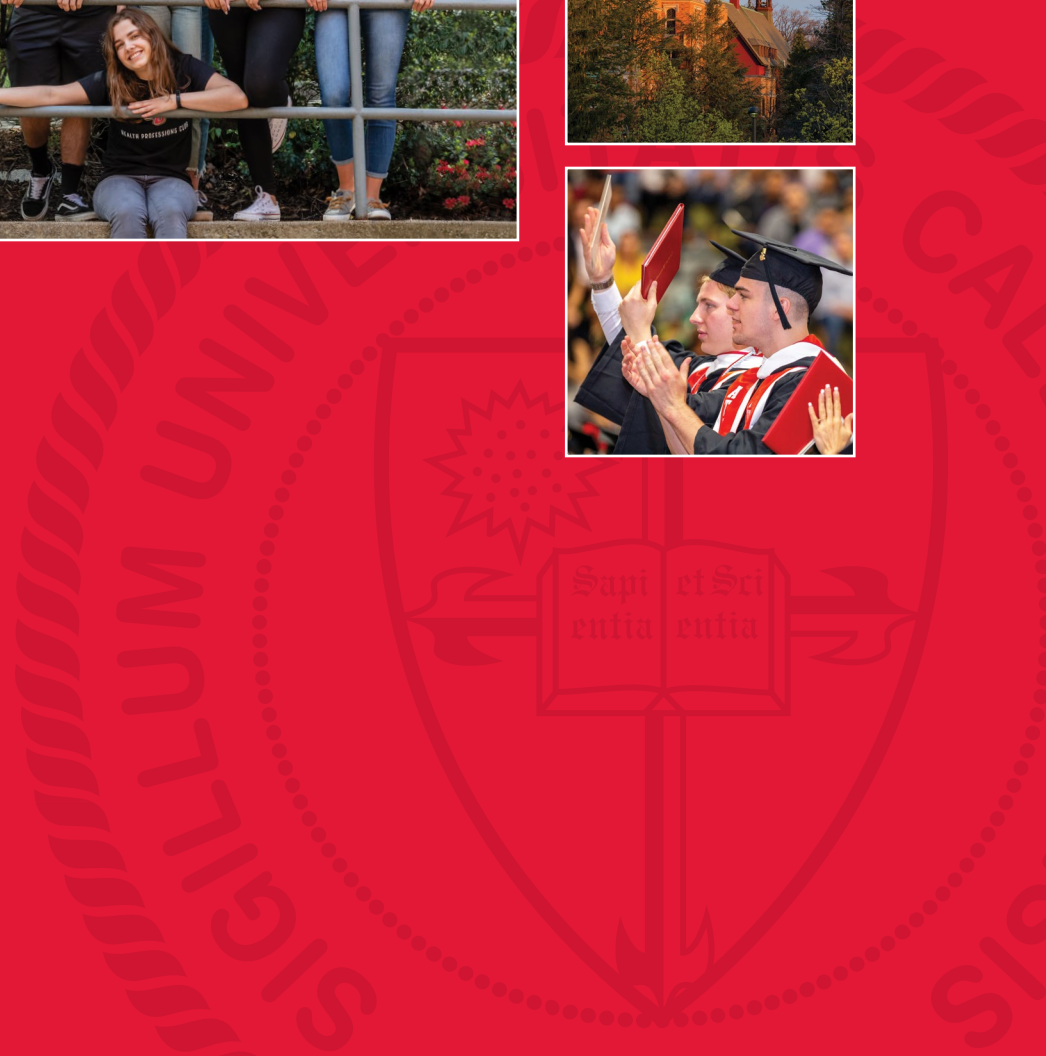




PRESIDENTIAL SEARCH PROFILE



THE UNIVERSITY

The Board of Trustees and the Members of the Sponsoring Congregation of the Sisters of Saint Dominic of Caldwell have begun an immediate search for the University's 10th president. The new president will succeed Caldwell's current leader, Matthew Whelan, Ed.D. following his departure on June 30, 2023 and upon the successful conclusion of the presidential search.



During President Whelan's tenure the University has achieved many significant milestones:

- Initiated SOAR Program to accommodate students with learning differences
- Added five new academic majors:
 - Exercise Science
 - Environmental Science
 - Communication Science Disorders
 - Business Data Analytics
 - Supply Chain Management
- Renovated student living and learning spaces including state-of-the-art lounges, classrooms and a Bloomberg Lab
- Raised \$3 million+ in private gifts
- Added two new varsity sports
 - Acrobatics and Tumbling
 - Men's Rugby
- Earned nearly \$1 million in competitive philanthropic grants
- Secured more than \$6 million in state/federal grants with another \$7 million+ pending

Caldwell University was founded in 1939 as a Catholic liberal arts college by the Sisters of Saint Dominic, under the leadership of Mother M. Joseph Dunn, OP, with the approval of the Most Reverend Thomas Joseph Walsh, Archbishop of Newark. Its original intent was to serve as an institution for Dominican sisters seeking higher education. Its first class included not only sisters, but other young women as well. In 1986, Caldwell became coeducational, enabling men to receive the same quality education women had been receiving for the previous 45 years.

The University is rooted in a proud, 800-year Dominican tradition of rigorous scholarship, committed teaching and ethical values. Serving a diverse population of all ages and faith backgrounds, Caldwell University provides an education that promotes spiritual, intellectual and aesthetic growth. In the Catholic humanist tradition, Caldwell strives to empower its students to be mindful of community and global issues. Annually, Founder's Day celebrates the spirit of the Dominican tradition that continues to influence life on campus.

HISTORY

Founded as a Catholic liberal arts college by the Sisters of Saint Dominic under the leadership of Mother M. Joseph Dunn, O.P., with the approval of the Most Reverend Thomas Joseph Walsh, Archbishop of Newark in 1939. The college, known as Caldwell College for Women, was incorporated on August 10, 1939 as an institution of higher learning for women under the laws of the State of New Jersey and empowered to grant degrees. The Most Reverend Thomas Walsh was its first president. Matthew Whelan, Ed.D. became the University's ninth and current President in July 2020.

In 1974, Caldwell College became the first institution in New Jersey to award the Bachelor of Fine Arts degree. In 1979, it became one of the few institutions in the state to offer a unique external degree program. In 1985, the Board of Trustees of the College voted to make Caldwell College fully co-educational, enabling men to receive the superior education and career preparation that women had been able to receive for forty-five years. Caldwell College welcomed its first full-time male students in the fall of 1986.

In November 1992, Caldwell College achieved new heights when the New Jersey Board of Higher Education granted approval for the College to offer the M.A. in Curriculum and Instruction. During the summer of 1993, the first graduate students began classes.

The college has consistently shown growth in the area of graduate studies. In 2000, Caldwell was the first higher education institution in New Jersey to offer an M.A. in Counseling with a Specialization in Art Therapy and in 2008 the first Post-graduate M.A. in Art Therapy.



In 2001, the college initiated a Post-baccalaureate Teacher Certification program in Special Education and a Dual Certification in Early Childhood and Elementary Education program. In 2003, the college began offering an M.B.A. program in the School of Business and CIS. That same year, the Behavior Analyst Certification Board, Inc.® approved a course sequence submitted by Caldwell as meeting the coursework requirement for taking the Board-Certified Behavior Analyst™ examination. In fall 2005, the college introduced an M.A. in Special Education and an M.A. in Applied Behavior Analysis. In the fall of 2009, the college's first doctoral program, a Ph.D. in Applied Behavior Analysis, commenced.



On December 9, 2013, Caldwell College received official notification from the Secretary of Higher Education in the State of New Jersey that it had been granted university status. Caldwell University commenced on July 1, 2014.

The University was approved to offer its second and third doctoral programs in the fall of 2014, a Ph.D. program and an Ed.D. program in Educational Leadership. In the fall of 2016, the University began offering another graduate program, M.A. in Higher Education. This program is offered in a fully online format. In 2019, the School of Nursing and Public Health launched a new fully online M.S. in Nursing degree in Population Health, the first of its kind in New Jersey. In addition, the School of Business & Computer Science launched a B.S. in Esports Management, the first in New Jersey and second in the nation.

The University currently offers 14 graduate degree programs as well as post-baccalaureate and post-master's degree programs.

Caldwell University is a private, Catholic, coed, four-year university with a strong liberal arts core curriculum that enhances critical thinking and analytical reasoning. Caldwell offers 36 undergraduate and 31 graduate programs, including doctoral, master's, certificate and certification programs, as well as online options that prepare students for today's global marketplace. The University has 15 NCAA Division II intercollegiate sports programs. Additionally, Caldwell offers two club teams, sprint football and rugby.

Caldwell offers numerous clubs, fraternities, sororities and activities. It is located on a beautiful 70-acre campus in suburban Caldwell, New Jersey. Graduate offerings include 31 advanced degree programs including: **Applied Behavior Analysis, Business, Counseling/Art Therapy, Nursing and Education**. These offerings provide flexible opportunities to earn masters, post-masters and doctorate degrees on campus with evening, weekend and accelerated programs, as well as online options available.

Caldwell's **School of Nursing and Public Health** is offering a fully online **M.S.N. in Population Health**, which is the first of its kind in New Jersey. Graduates will be qualified to work in a variety of healthcare systems in positions that include: care coordinators; project, case and nurse managers in outpatient facilities, hospitals, and public health departments; and within insurance and quality improvement fields. They will also be qualified to teach in undergraduate nursing programs upon the completion of their M.S.N. degree.

ACCREDITATIONS

Caldwell University is accredited by the Middle States Commission on Higher Education.

Several of the University's academic programs have received specialized academic accreditations. Caldwell University is accredited by the Accreditation Council for Business Schools and Programs to offer the following programs: B.S. in Business Administration, B.S. in Accounting, B.S. in Financial Economics, B.S. in Marketing, M.B.A., and an M.B.A. with a concentration in Accounting.

Caldwell University's teacher preparation program and selected education-related master degree programs were accredited in fall 2013 by the Teacher Education Accreditation Council and by the Inquiry Brief Commission of the Council for the Accreditation of Educator Preparation for a period of seven years, from October 2013 to October 2020.

Caldwell University's graduate programs in clinical mental health counseling and clinical school counseling received accreditation from the Council for Accreditation of Counseling and Related Educational Programs (CACREP) in spring of 2012. The graduate program in clinical mental health counseling with art therapy specialization received accreditation in 2015, becoming the first program of this type to receive CACREP accreditation in the nation. In addition, this program is approved by the American Art Therapy Association.



In spring 2012, the B.S.N. program received accreditation through the Commission on Collegiate Nursing Education. The accreditation was reaffirmed in 2017.

In 2014, the University's M.A. in Applied Behavior Analysis program received accreditation from the Association for Behavior Analysis International.





Caldwell University fields 15 NCAA Division II athletic programs that participate in the Central Atlantic Collegiate Conference (CACC). Additionally, we offer two additional varsity sports, sprint football and rugby, which are not sponsored by the NCAA. Our intercollegiate programs include:

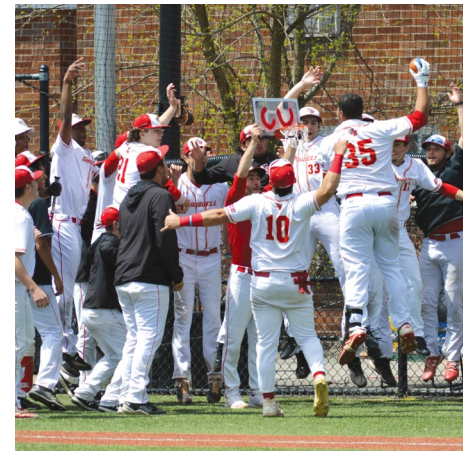

Internships, cultural activities, skiing, beaches and sporting events are easily accessible using public transportation.

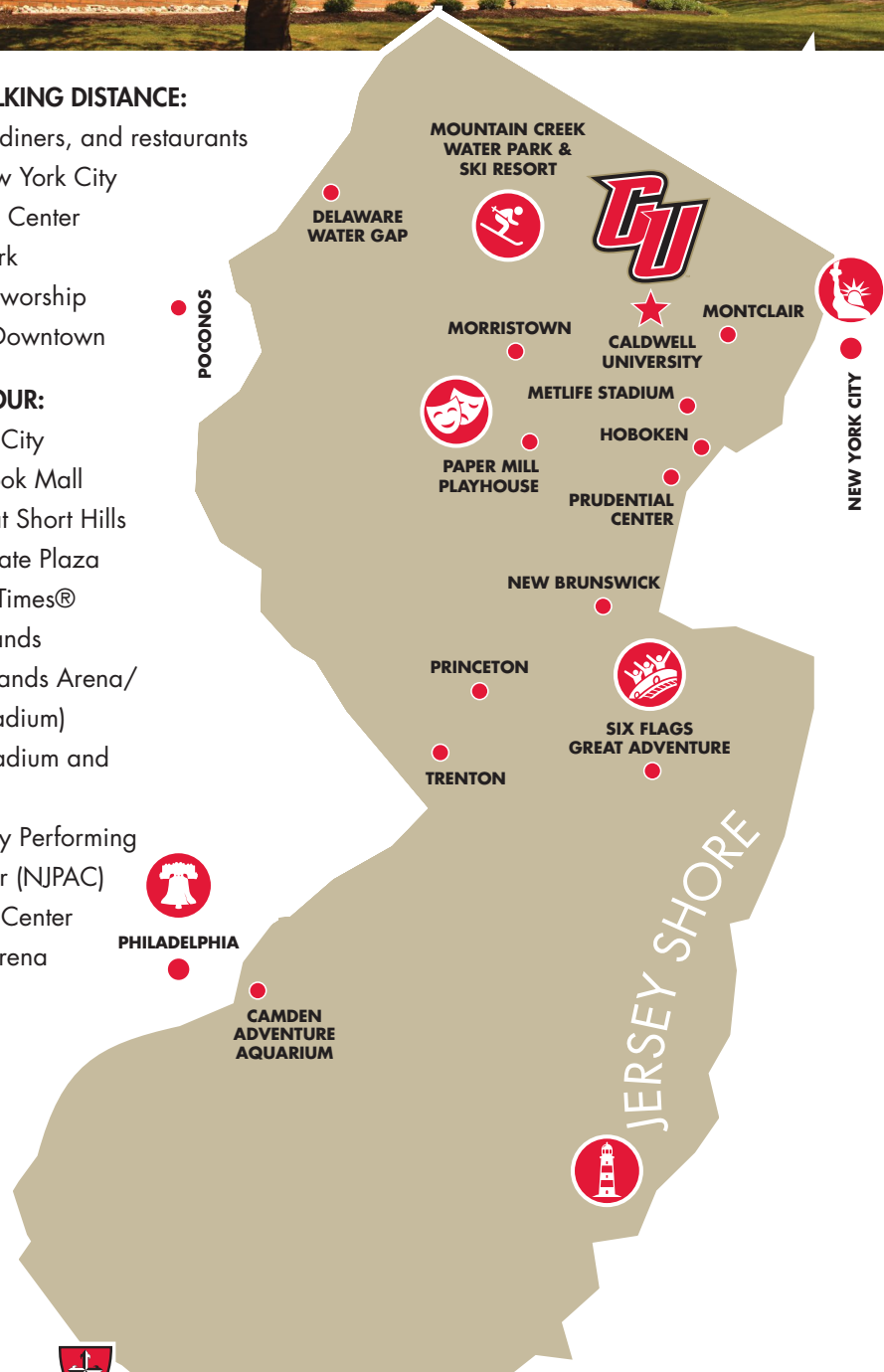

The President serves in an ex officio capacity on the Board of Trustees and on the following committees:

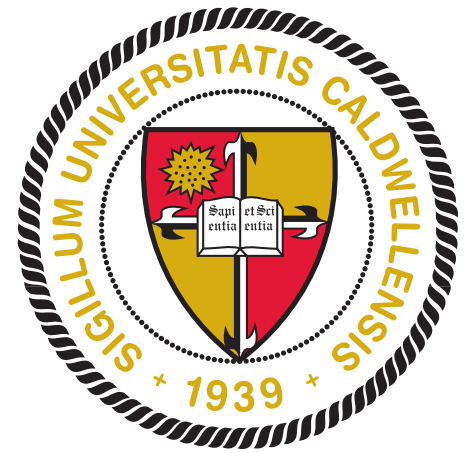
